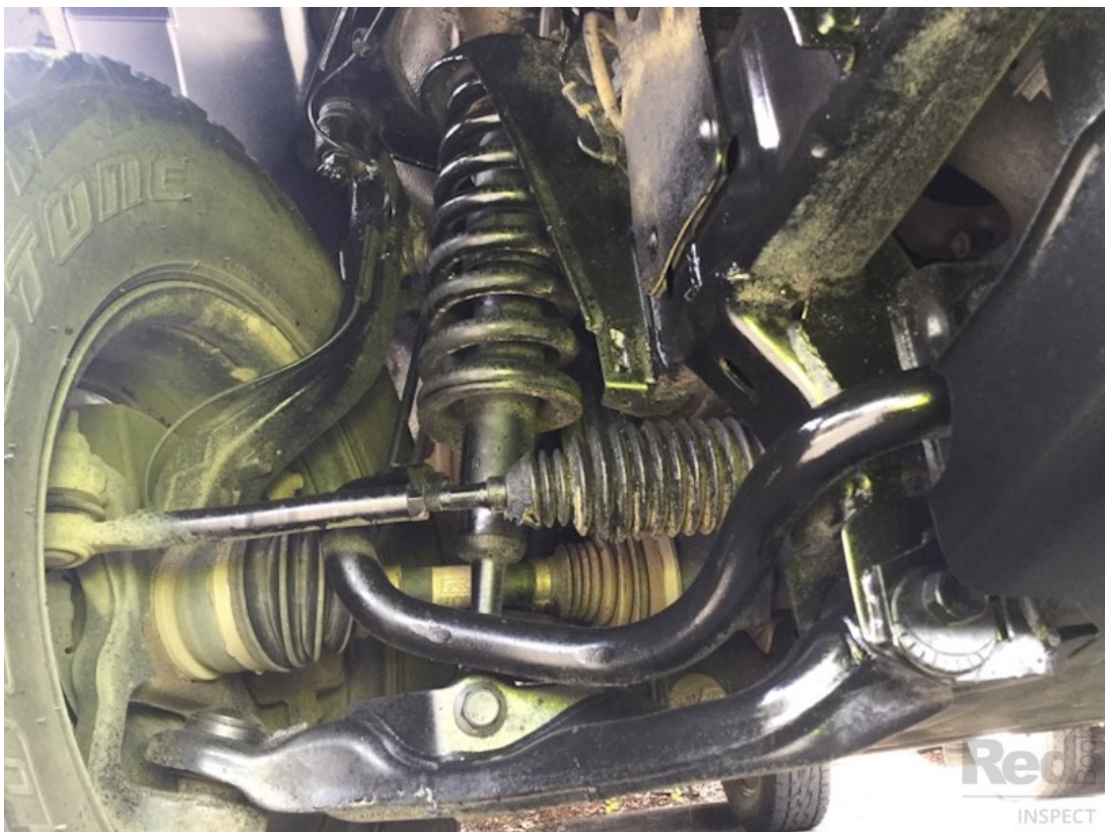


General Comments
