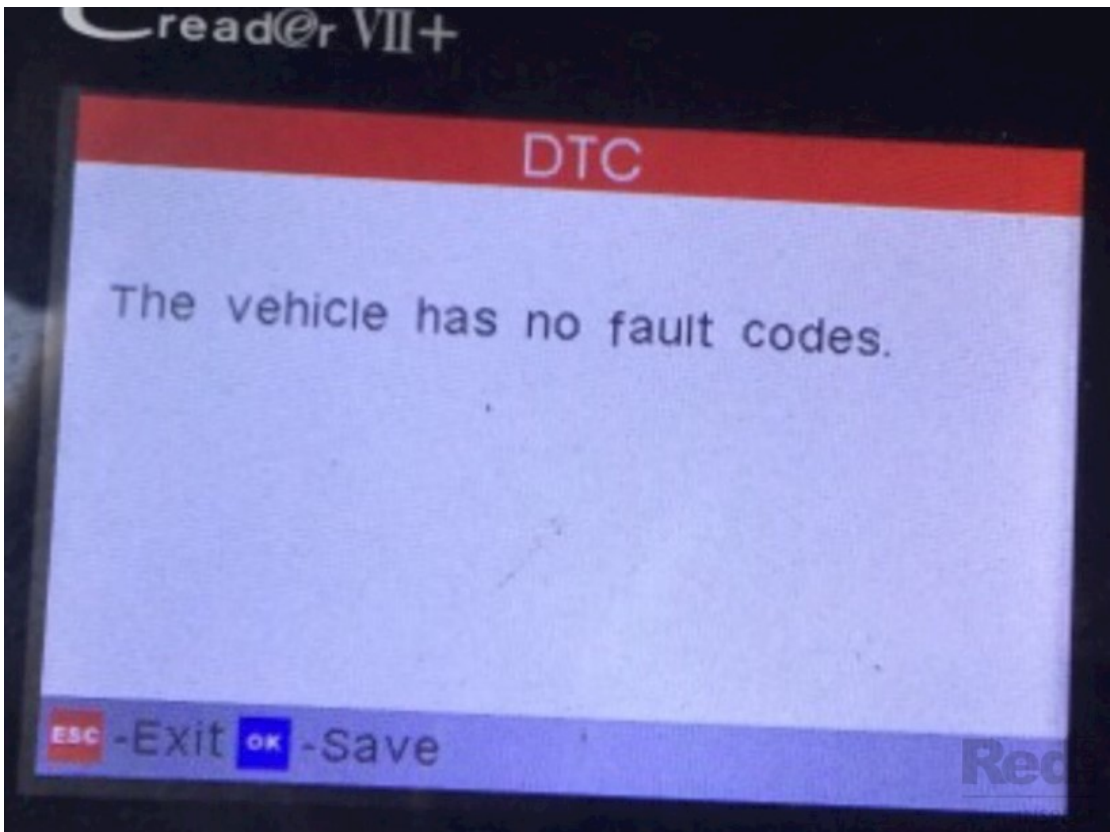
General Comments
