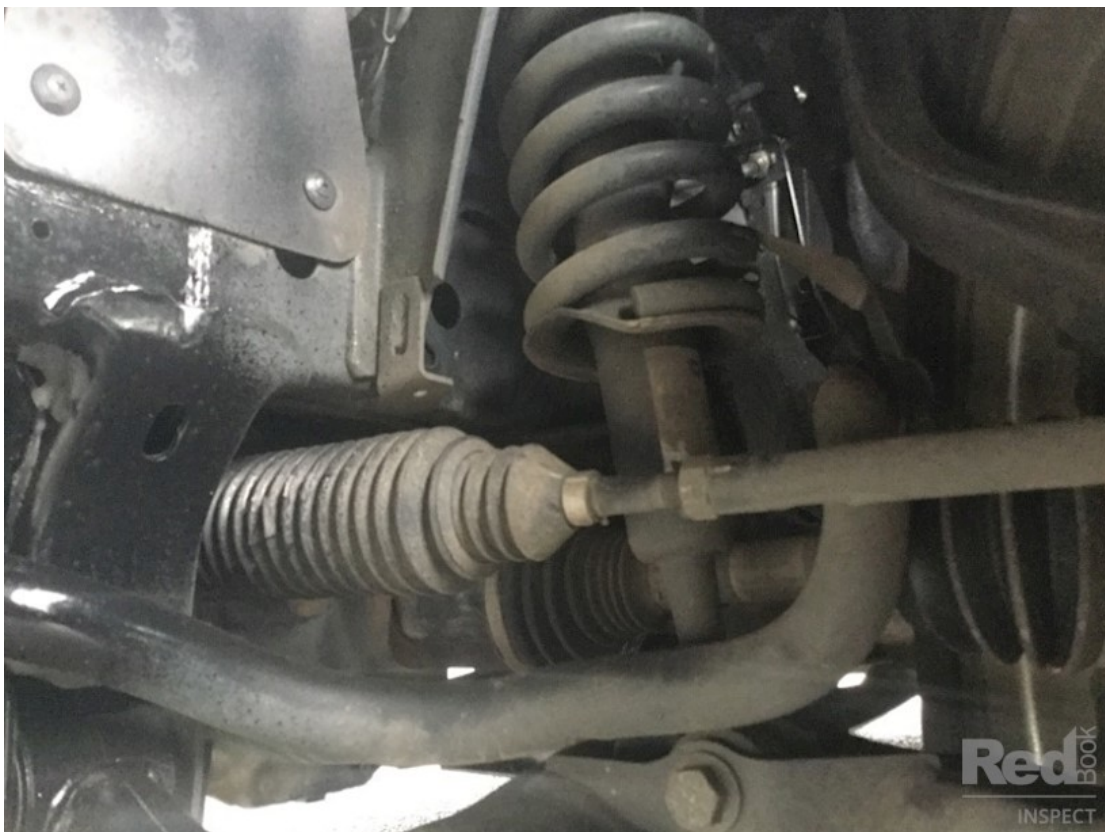
General Comments
