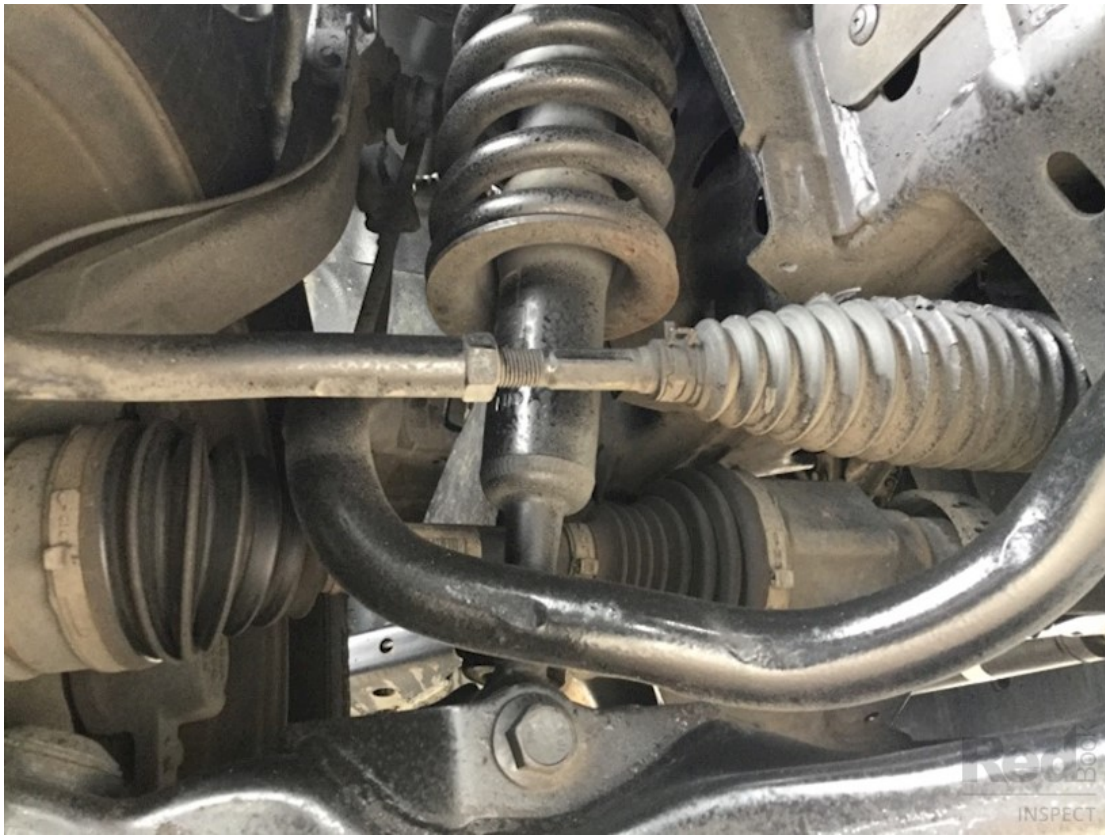
General Comments
