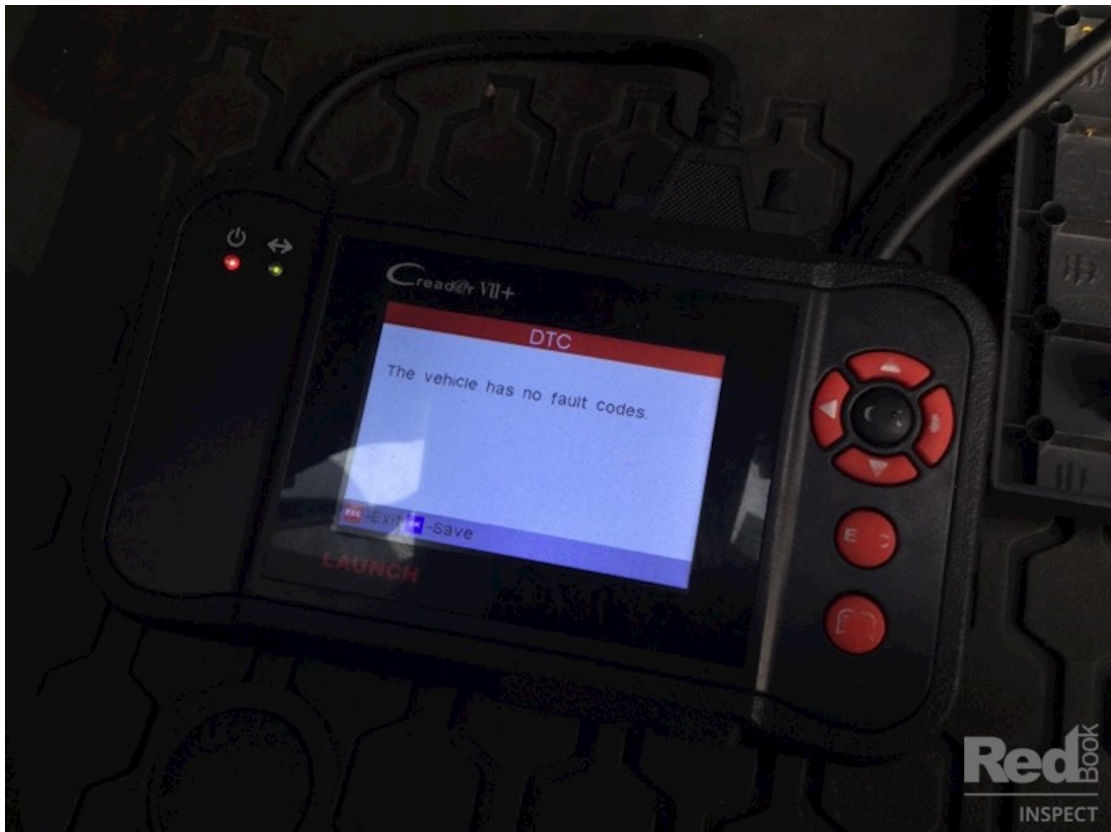

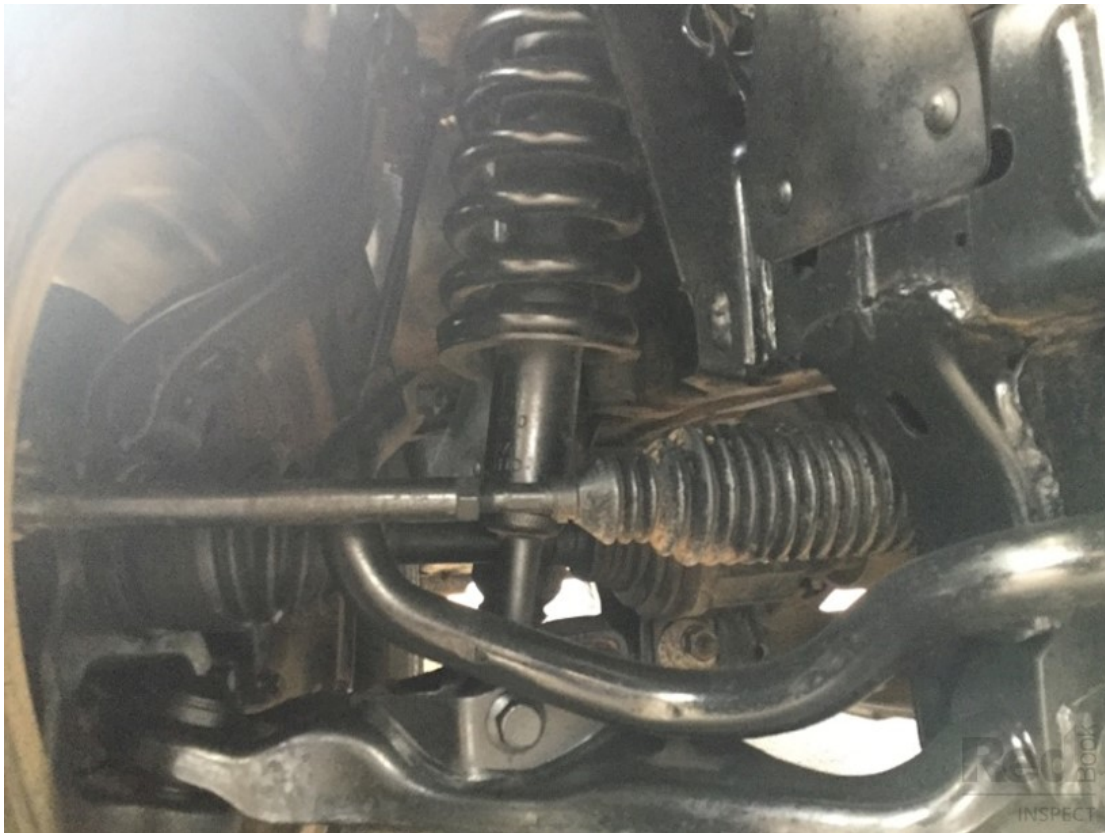
General Comments
