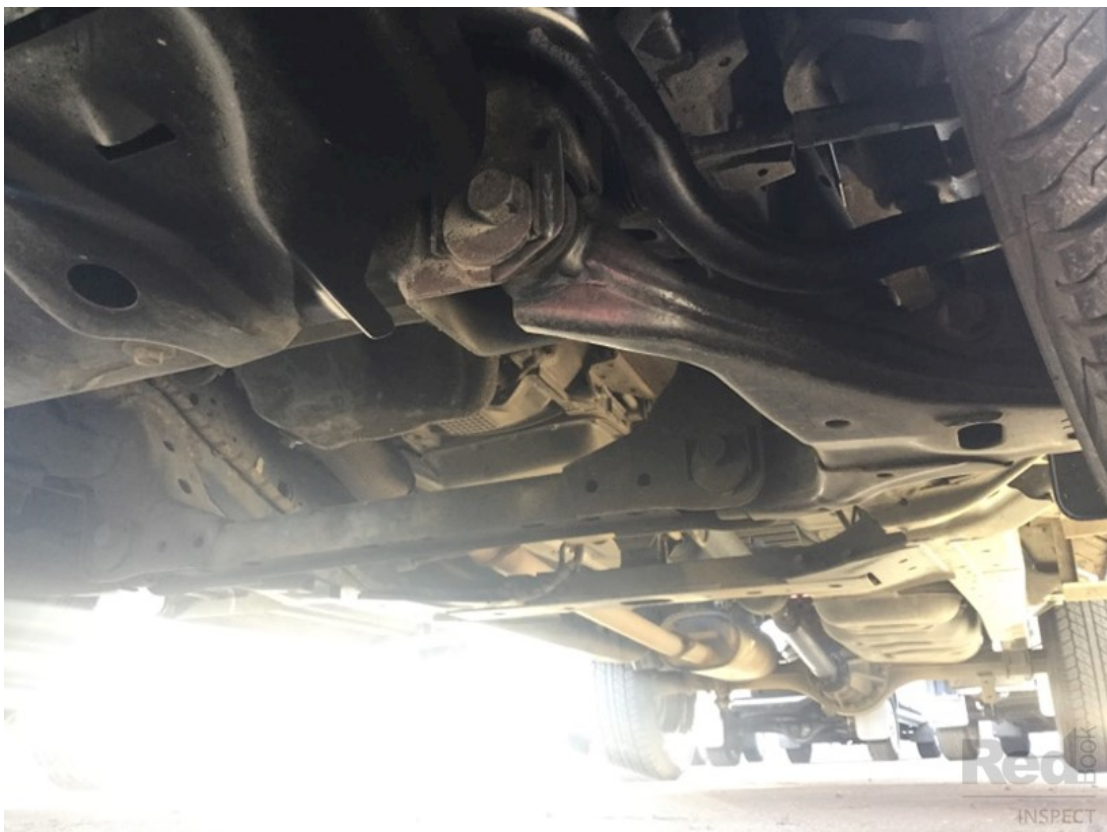


General Comments
