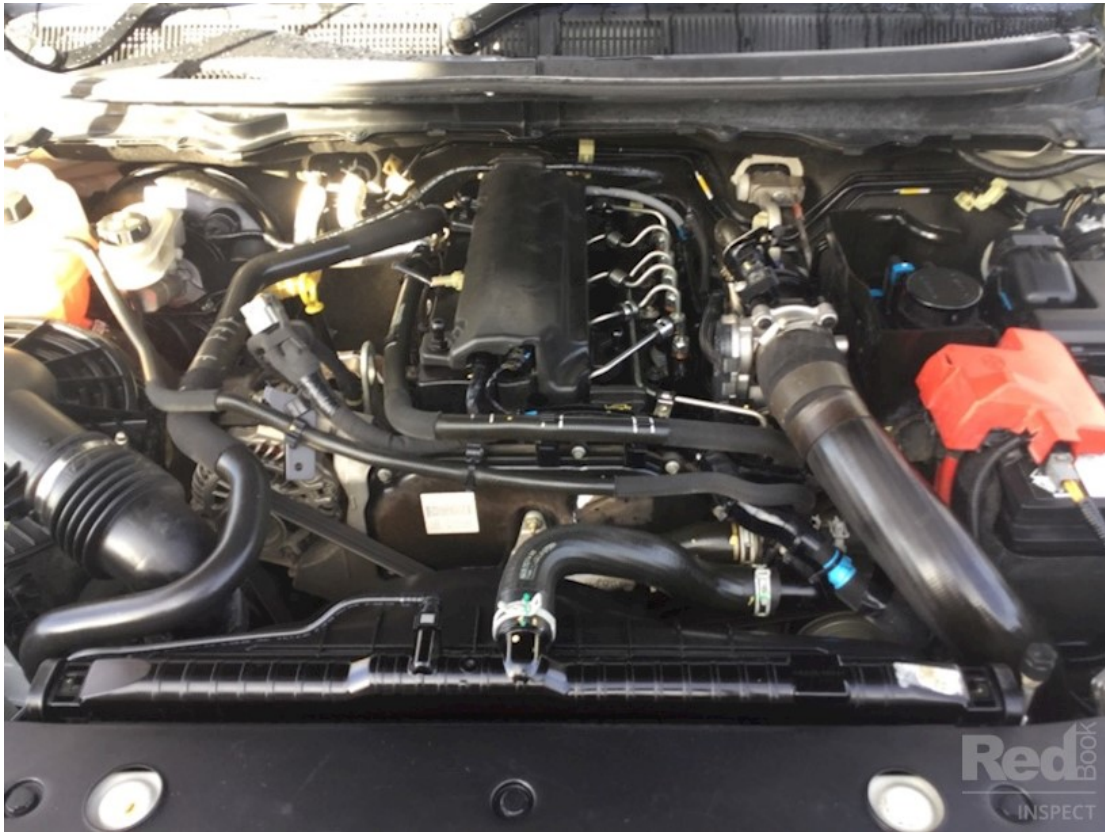


General Comments
