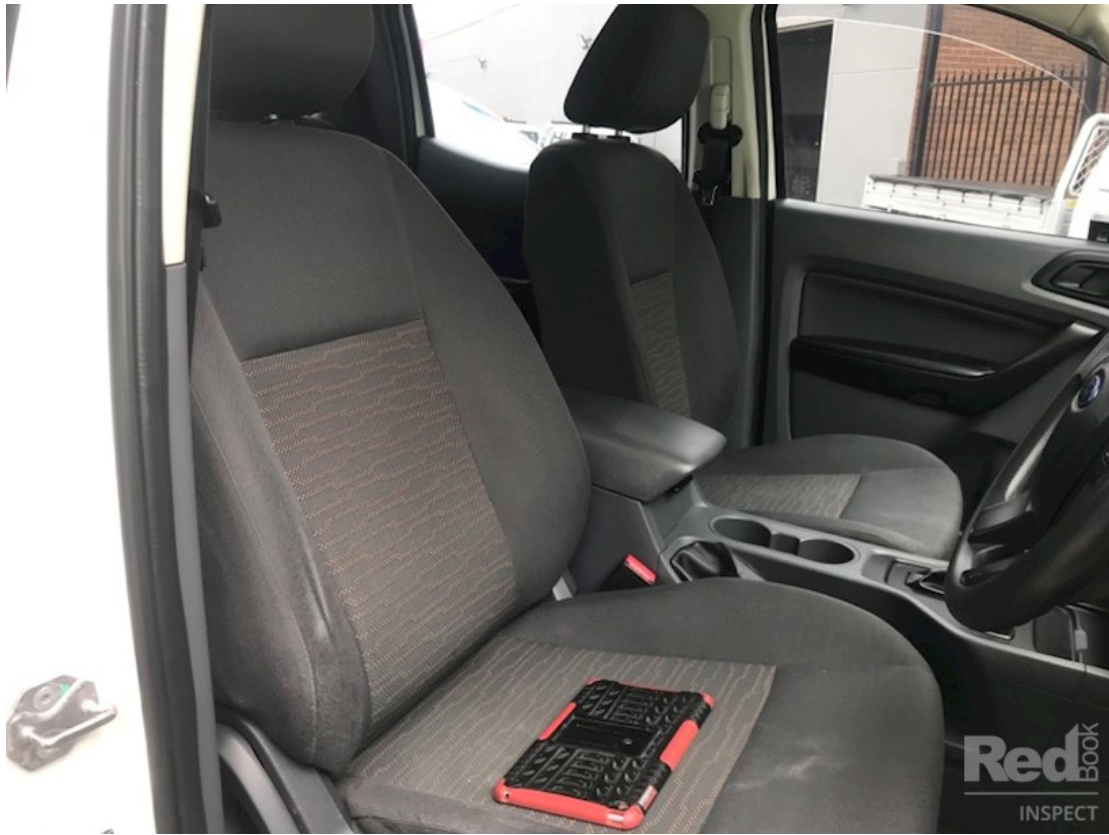

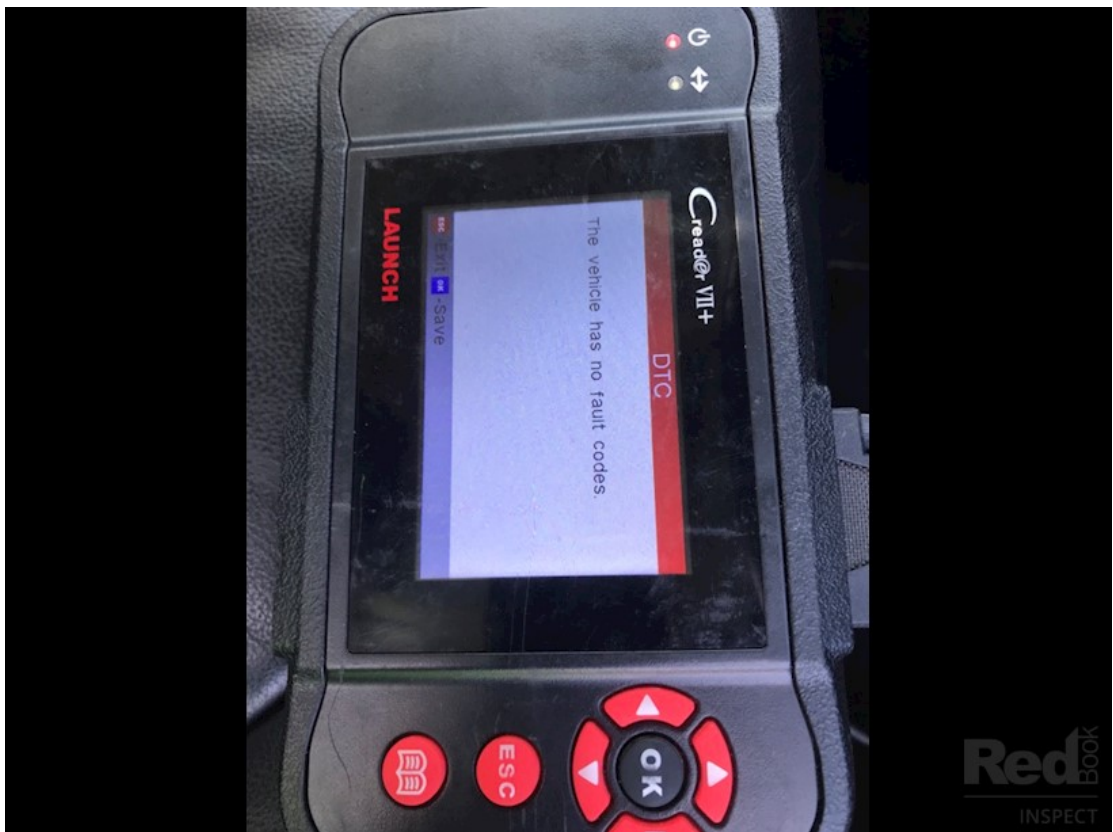

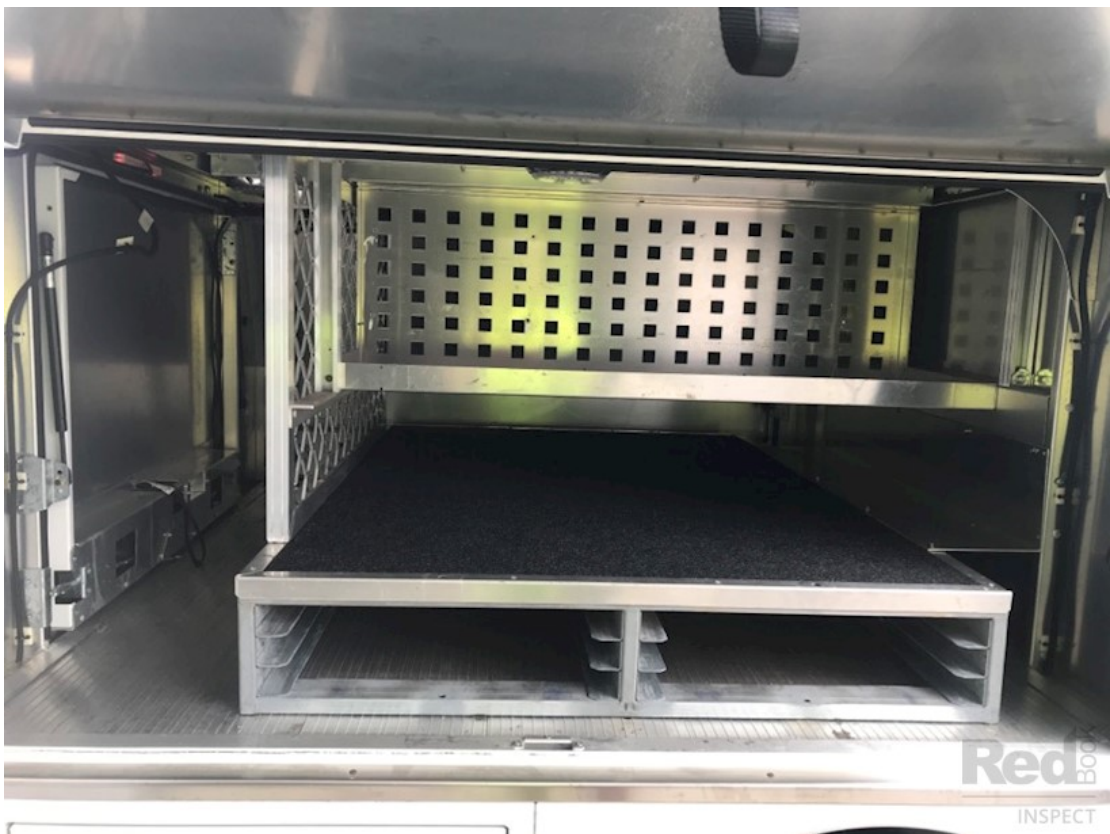
General Comments
