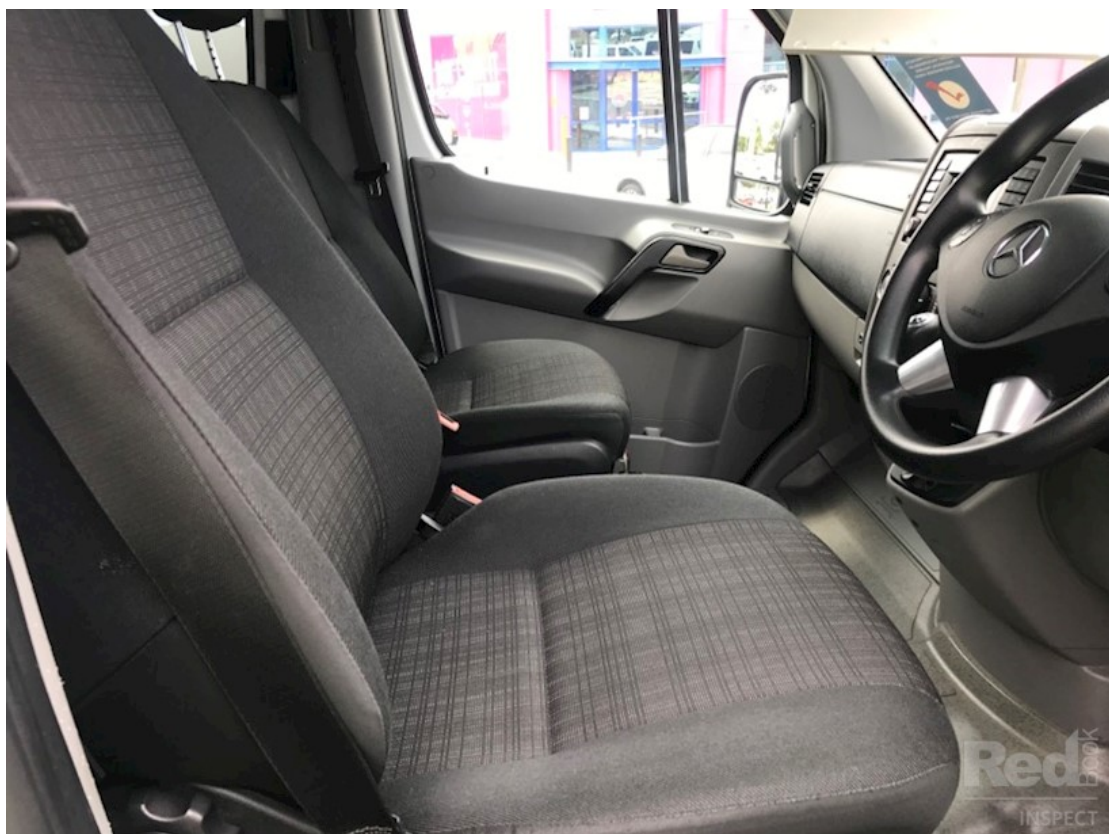

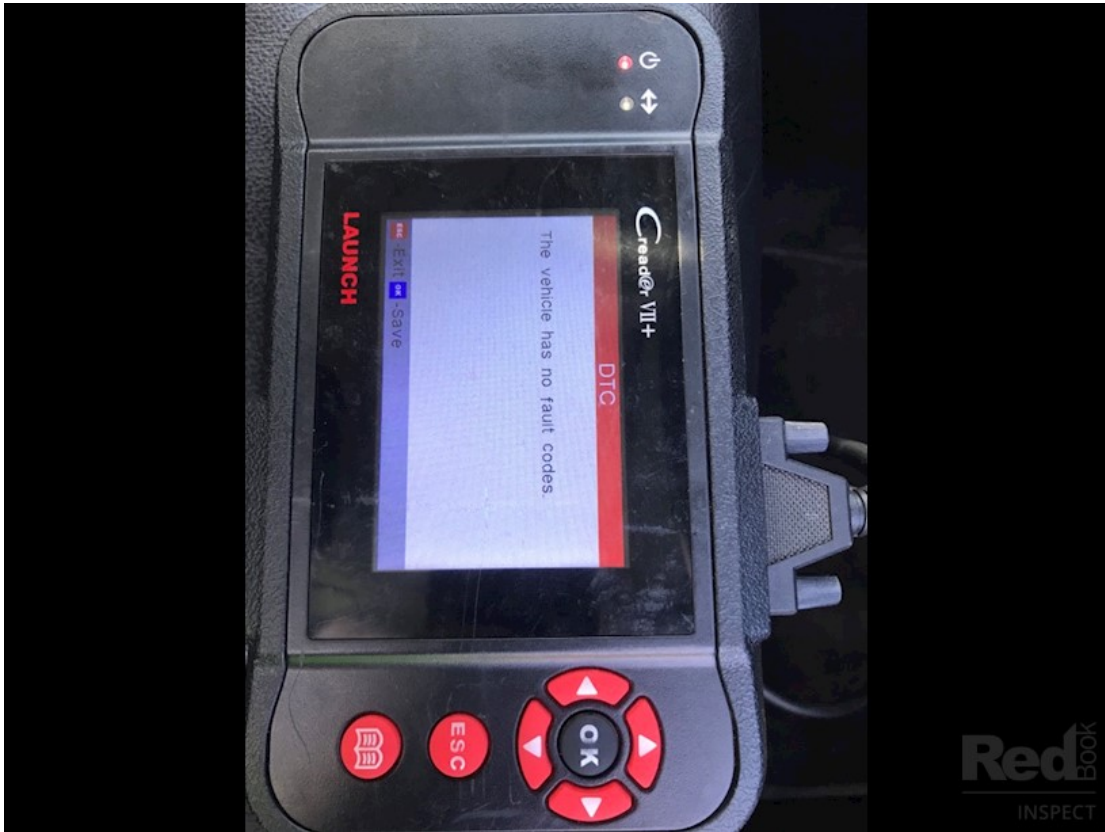


General Comments
