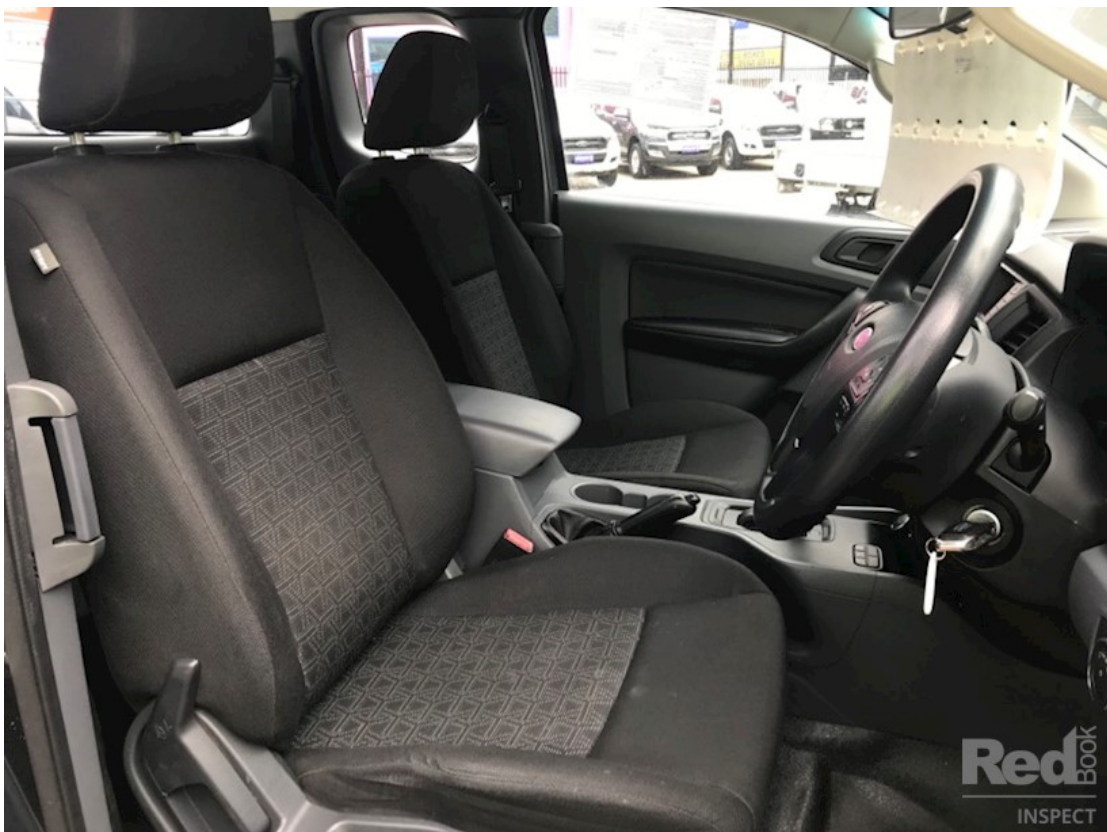

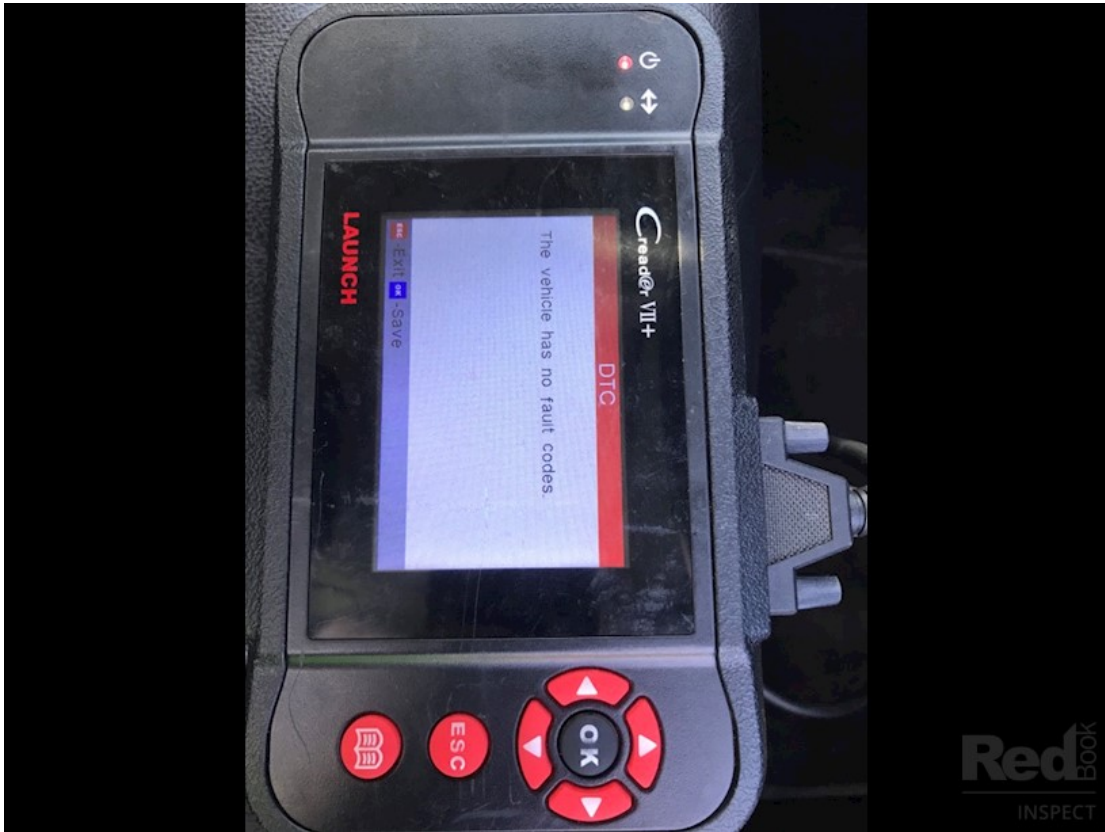


General Comments
