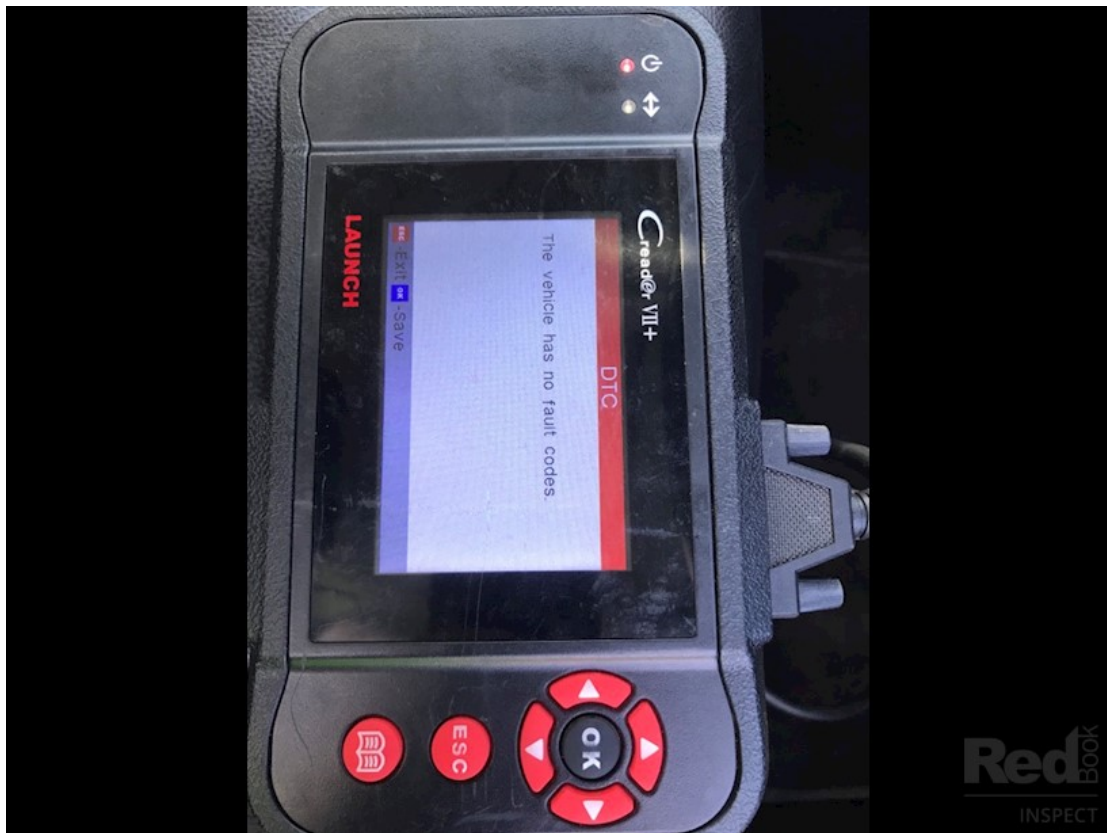


General Comments
