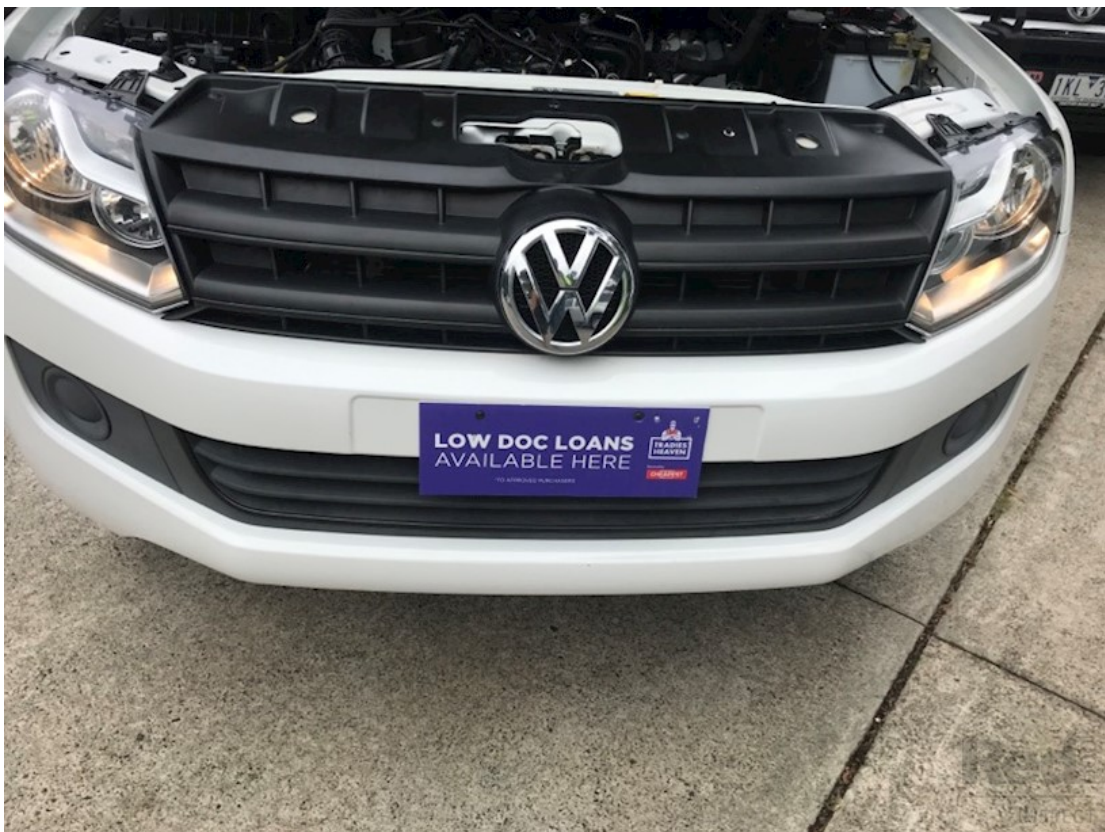
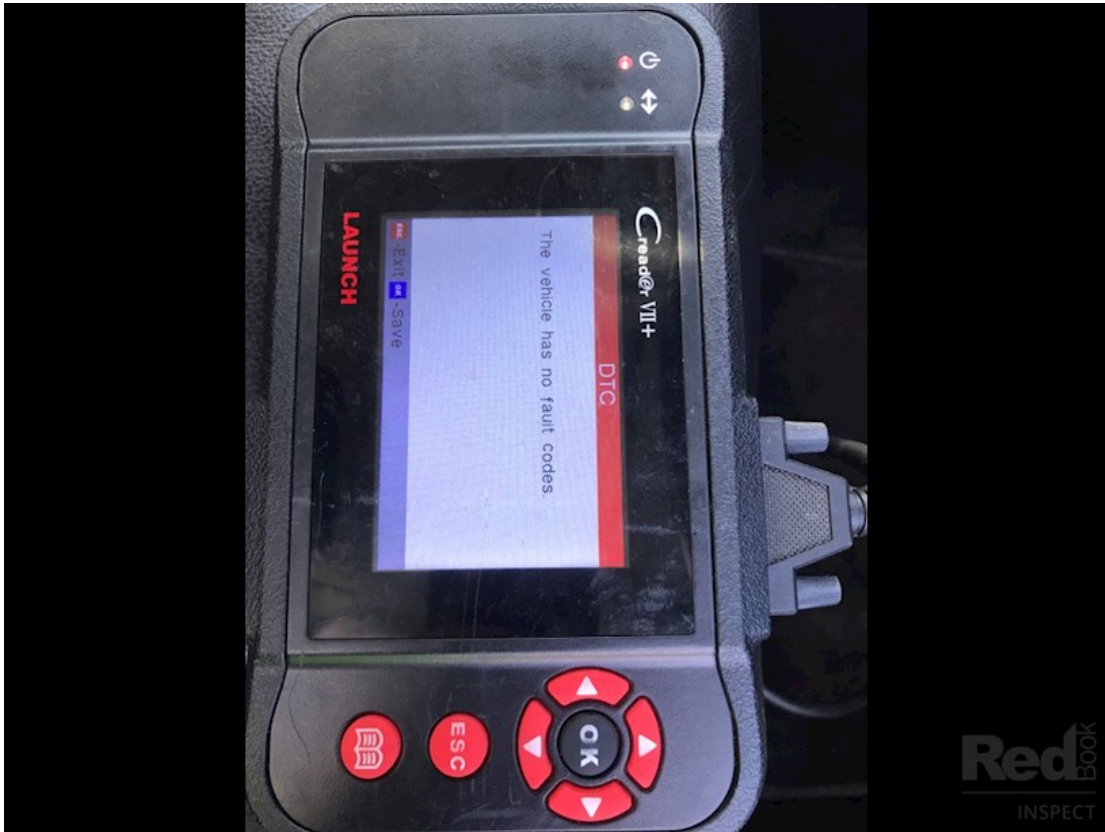


General Comments
