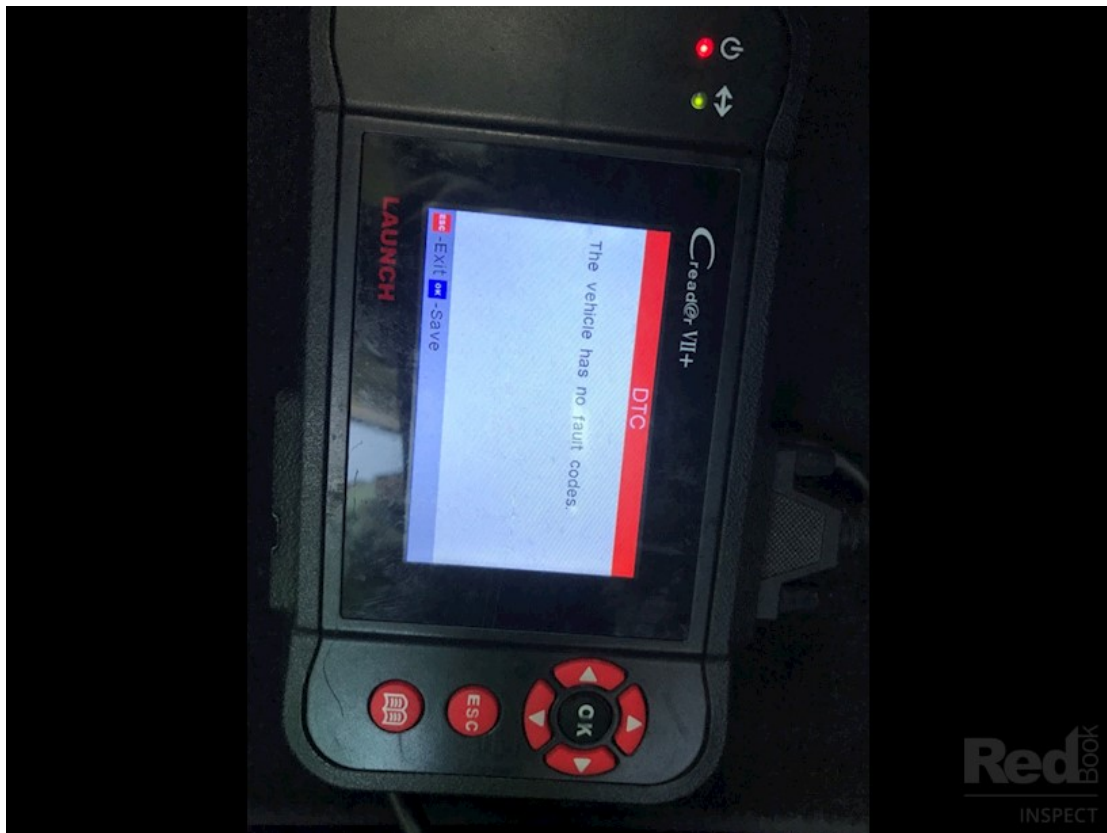


General Comments
