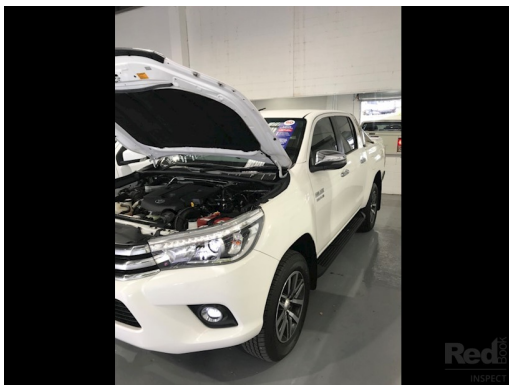

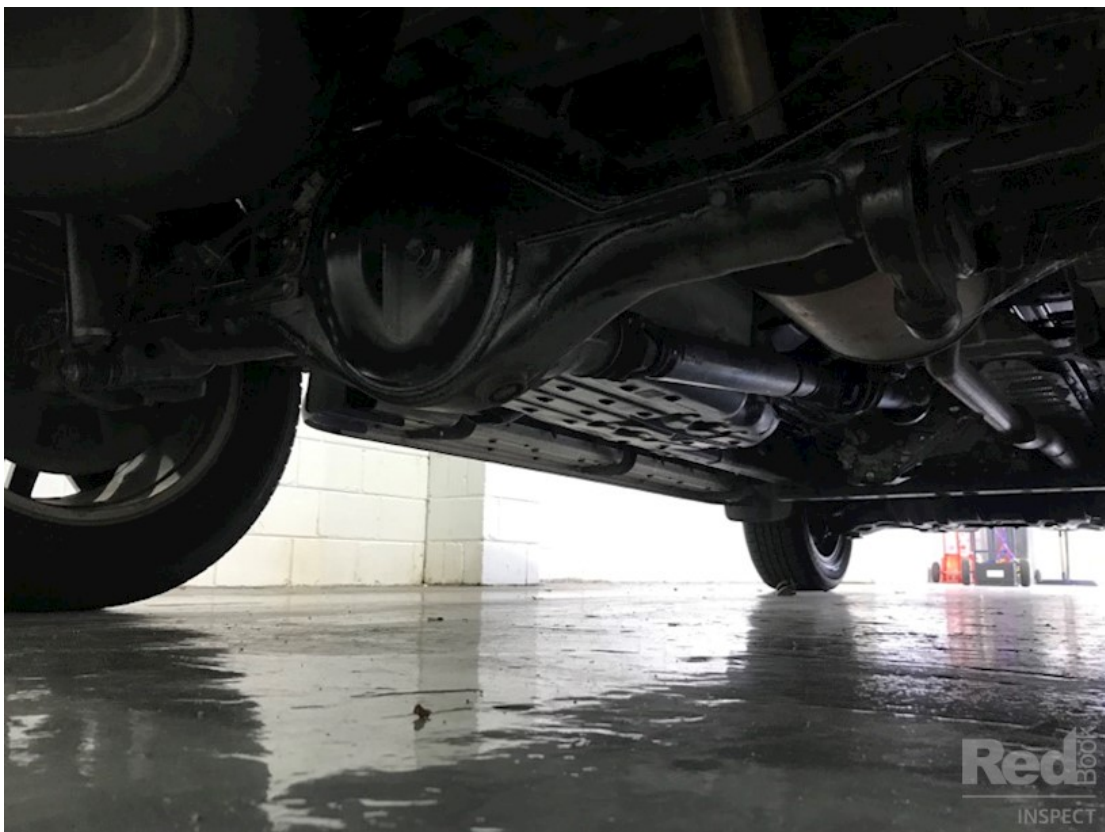
General Comments
